# Rates increase slightly in February.

Rate information: Rates increased 2 basis points (0.02%). We do expect more rate adjustments through the rest of the year. Rates should be stable for the next 6 months. There has been an easing of the debt refinance rules by the SBA with the new SOP.

The SBA's turnaround time for approvals is 2.7 business days, and servicing action times are also 3.8 business days.

We had 2 SBA approvals in January, year to date we have 11 SBA approvals.
